

At 8:00 a.m., Chairman Klose called the mid-month meeting of the Stutsman County Commission to order. Mark T. Klose, Dennis Ova, Dale Marks, Craig Neys, and David Schwartz answered the roll call.

Sandra Eckelberg, Accounts/Property Coordinator for Stutsman County Auditor's Office, presented the list of foreclosure properties which includes the minimum bid requirements. The property auction will take place November 18<sup>th</sup>, 2014 at 10:00 a.m. in the courthouse. Schwartz made a motion, seconded by Ova to approve the foreclosure properties, the minimum bid prices, the time, date, and location of the auction. Roll call vote: Ova, Marks, Schwartz, Neys, Klose voted aye.

Bryan Schouvieller, Senior Vice President of Ag Business Group for Cenex Harvest States (CHS) gave a presentation of the Spiritwood, North Dakota fertilizer project. CHS is the nation's leading cooperative which is owned by farmers, ranchers and cooperatives throughout the United States. The main businesses are energy, food, grain products, and marketing. They have 600,000 producers through the 1,100 member cooperatives and CHS retail locations. CHS has operations in 24 countries as well as customers in 65 countries. The number one goal is to bring value and to provide access to local and international markets for producer owners. CHS chose Spiritwood, North Dakota because of the desire to secure supply, vertical integration; placing supply with demand, and the availability of market access. The project status: it is a Board Of Directors (BOD) approved project; staffing Project Management Operation (PMO) structure; all of the necessary permits have been completed; they are working on the contracts, system, and procedures; they are working on a viable source for water; and need enough temporary housing for the construction workforce. CHS is working with the Emergency Management Department, the Sheriff's Office, the Fire Department, and medical facilities. CHS will require certain security guidelines to be met for the site personnel and man camp such as camp curfew, require employment background check, pre-hire, random and for-cause drug and alcohol screenings to name a few. CHS is predicting they will have approximately 28,153 truck shipments and a significant amount of rail shipments annually. Cenex Harvest States received the full notice to proceed in September 2014. CHS is looking at the viability of a water treatment facility to meet the demand for water which would be operated by the Stutsman County Rural Water District. They will have a better idea if this avenue will work by the middle of November.

Casey Bradley, Auditor/COO, presented the CHS Property Tax Incentive agreement for Payment in Lieu Of Taxes (PILT) and the Public Hearing for Property Tax Incentive. CHS has proposed a fertilizer plant that will take multiple years to construct with a total project cost of \$3 billion. CHS requested an incentive package from the state and local governments. Property tax incentives are governed by North Dakota Century Code 40-57.1-03. A committee comprised of the local taxing jurisdictions was created to negotiate with CHS. The Stutsman County Commission gave a directive that no proposal would be considered that reduced property tax payments that were created during construction. In January 2014, the county received a request from CHS initiating property tax negotiations. Stutsman County contracted with Thos. Y. Pickett & Company to come up with an estimated value for the purposes of negotiation. The Stutsman County negotiating committee was established in accordance to N.D.C.C 40-57.1-03. Thos. Y. Pickett & Company and CHS agreed upon a value which was accepted by the county commission in March 2014. From June to September 2014 CHS and county staff worked through assessment processes and construction schedules for the fertilizer project. The Negotiating Committee approved the requested CHS PILT proposal in September 2014. The county has met with all of the impacting taxing jurisdictions and JSDC approved the incentive funding for the PILT shortfall. The CHS project is projected to cost \$3 billion, the estimated value

less personal property is \$1,200,000,000. An inherent risk factor of 25% was applied bringing the estimated true and full value of the project to \$900,000,000. The assessed value is \$450,000,000 which is 50% of the true and full value. The taxable value is ten percent of the assessed value which is \$45,000,000. In 2014 which is the 2013 tax year the county value is \$80,355,287. This is a 56% increase in value of the county when the project is complete. The construction schedule will be based on an assessment cycle versus a calendar year; the annual payment of \$3,235,000 will be made to fulfill the board directive of no reduction of value during the incentive period. CHS has requested that it will not pay more than \$3,000,000 during its requested 20 year PILT period. JSDC has voted to use its incentive fund for the remaining \$235,000 per year with the funding being 10% city and 90% county. This proposal was accepted by the negotiating committee and recommended to the commission for approval. CHS will be bound to the provisions of the agreement and their application. CHS agreed to employ 177 FTE's at the Spiritwood facility, create the value as proposed and only operate the facility as proposed. The payments for local governments are as follows: the payment for the county is \$2,171,937 or 24% of current tax revenues, \$50,725 or 89% of current tax revenues for the township; \$62,949 or 50% of current tax revenues for the fire district, and \$949,389 or 53% of current tax revenues for the school district. Barnes County North School District will be meeting with their board tonight. The school may potentially lose 75% of the PILT funding right off the top and goes to the State of North Dakota. The negotiating committee approved the payments would be locked for a 20 year period beginning with the commercial operation of the facility which is projected to commence in 2018. The CHS fertilizer facility is the largest project in the history of North Dakota. Currently, OneOK Rockies Midstream LLC is the largest project with a true and full value of \$273,284,340 and the largest taxpayer at \$1,377,434 per year. CHS would become the largest single project taxpayer in the state by 2.3 times during the incentive period. Currently in Stutsman County, Cargill Inc. has the largest property value which is at \$42,645,000.

Joseph M. Schmitt gave a presentation to the Stutsman County Commission which referred to the September 9<sup>th</sup>, 2014 "CHS Agrees to Pay \$3 Million Annually" article in the Jamestown Sun.

Schwartz made a motion, seconded by Neys to approve the CHS Property Tax Incentive as presented. Roll call vote: Marks, Schwartz, Neys, Klose, Ova voted aye.

Scott Wegner, bond counsel, drafted the PILT contract for Stutsman County. The contract was presented to the Barnes County North Public School District No. 7, Spiritwood Township, Jamestown Rural Fire District, Jamestown/Stutsman Development Corporation (JSDC), and CHS Spiritwood Fertilizer LLC. The county did not receive any feedback from the local taxing jurisdictions. Marks made a motion, seconded by Ova to approve the PILT contract as presented. Roll call vote: Schwartz, Neys, Klose, Ova, Marks voted aye.

Connie Ova, JSDC, requested approval on the CHS Incentive Funding. Stutsman County established a Property Tax Negotiating Committee to negotiate a property tax incentive package with CHS for the fertilizer plant. The committee had a directive from the commission to recommend an incentive package that does not decrease property tax revenue created during construction through the incentive period. The county estimated the minimum amount of any incentive package must result in an annual property tax payment equal to or greater than \$3,235,000 for the life of the incentive period. CHS formally requested that payments do not exceed \$3,000,000 for a period of 20 years as a payment in lieu of tax. It is the committee's recommendation the proposal of \$3,235,000 is recommended for approval and to request that JSDC participate with an incentive of \$235,000 over the 20 year period beginning January 1, 2019. The county's portion would be at 90% or \$211,500 and the city's portion is ten percent or \$23,500. JSDC will serve as the local grantor to allow the CHS Inc. fertilizer plant the ability to receive 95% reimbursement of the eligible New Jobs Training Funds dollar amount of \$4,570,875

which is \$4,342,331 over a ten year period. JSDC will facilitate CHS Inc. being able to receive 95% reimbursement of the New Jobs Training Funds. Without JSDC assistance, the company can only self-fund at 60% which equals \$2,742,525 which would leave \$1,599,806 unused of this incentive. Ova made a motion, seconded by Schwartz to approve the CHS Incentive Funding and to have JSDC act as a facilitator for CHS Fertilizer's New Jobs Training Program. Roll call vote: Neys, Klose, Ova, Marks, Schwartz voted aye.

Connie Ova requested approve for a Flex PACE Interest Buy Down for D & B Portables. Bonnie and Donald Larson, dba D & B Portables LLC is requesting a Flex PACE Interest buy down to open a portable restroom service business. This venture will create two new full-time positions. They plan to hire two additional full-time employees within the initial twelve months. The community share is \$43,000 with an 80% / 20% split between the city and county. The cost to the city is \$34,400 and \$8,600 would be the county's portion. D & B Portables will be leasing space at 1513 Business Loop East in Jamestown. They have secured financing with the Bank of North Dakota and Northland Financial Bank in Medina. Marks made a motion, seconded by Neys to approve the request as presented. Roll call vote: Klose, Ova, Marks, Schwartz, Neys voted aye.

Connie Ova received a request from Tim and Kathy Nill, dba Nill Construction, Inc. to purchase Lot 8, Block 1 in the I-94 Business Park. The lot is listed at \$1/square foot or \$68,171. Nill Construction is planning to construct a shop and office. Ova made a motion, seconded by Marks to approve the request as presented. Roll call vote: Ova, Marks, Schwartz, Neys, Klose voted aye.

Connie requested to set aside 30-40 acres of land for a potential crew camp for temporary workers for the upcoming Spiritwood construction projects. The crew camp would be located at SW ¼ 28-140-62, JSDC Spiritwood Property. The annual lease rate would be \$600/acre for the property. The proposed crew camp owner/operator is required to enter into a lease agreement with either CHS, Inc. and/or the general contractor and would follow the Stutsman County crew camp ordinance. The property has all of the amenities such as water, sewer, electricity, gas, and internet. Neys made a motion, seconded by Schwartz to approve the request as presented. Motion Carried.

Dustin Bakken, Tax Director, presented his monthly report. The integration of Orion and TaxWise is moving along and will be having live data as of today into our tax system. The GIS Ag land soils project into Orion is complete and will be imported within a couple of weeks so the county can calculate 2015 Ag land values. The Taxation Committee meeting met in September in Bismarck. The committee wants to do away with the list of modifiers which has been a hot topic with the State Equalization Board due to the abuse of modifiers. The county does not use modifiers; the county goes off of actual use. The committee is not in favor of land use and a few of the committee members would like to see a straight value across the board. The Tax Department will be holding an Ag land valuation course in November for assessment officials. This is Tyler's last class and will be a certified county tax director. Dustin has contracted with the Association of Counties and State Tax Department to teach Ag land valuation classes. There will be no impact to Stutsman County.

Jerry Bergquist, 9-1-1 Coordinator/Emergency Manager, received the Distinguished Service Award which is the highest award North Dakota Emergency Management Association gives to honor current members who, through their long-term efforts, have clearly influenced the field of Emergency Management and the work of the Association in a positive manner. He was nominated by Greg Wilts, Division of Homeland Security.

Bergquist requested approval to add five new members and delete nine members from the

Stutsman County Local Emergency Planning Committee (LEPC). Ova made a motion, seconded by Schwartz to approve adding five new members and deleting nine members to the Local Emergency Planning Committee as presented. Motion Carried.

Marks made a motion, seconded by Ova to appoint Commissioner Schwartz to the Canvas Board. Motion Carried.

Schwartz made a motion, seconded by Ova to approve the taxable meals and mid-month bills. Roll call vote: Marks, Schwartz, Neys, Klose, Ova voted aye.
